I. COVID INFORMATION:

II. COURSE INFORMATION

- **A.** <u>COURSE DESCRIPTION:</u> A study of accounting for merchandising, notes payable, notes receivable, valuation of receivables and equipment, and valuation of inventories in a manual and computerized environment.
- B. <u>PRE-REQUISITES</u>: There are no prerequisites for this course. This course is designed for transfer to colleges and universities offering a Bachelor of Business Administration degree.

C. <u>LEARNING OUTCOMES:</u>

- **1.** Students will recognize commonly used financial statements, their components and how information from business transactions flows into these statements
- **2.** Students will demonstrate progressive learning in the elements of managerial decision making, including planning, directing and controlling activities in a business environment.
- **3.** Students will be able to demonstrate progressive learning of various tax issues and tax forms related to individuals.
- **4.** Students will be able to demonstrate knowledge of preparation of Financial Statements and or financial schedules in accordance with Generally Accepted Accounting Principles through analysis and synthesis of information as well.
- **5.** Students will be able to demonstrate knowledge in setting up a computerized set of accounting books for a "for profit" entity.
- **6.** Students will demonstrate progressive affective domain development of values, including but not limited to receiving and responding to: the role of accounting in society, business ethics, environmental and global societal sustainability, and/or career opportunities. In advanced accounting courses beyond the introductory level, affective development will also progress to the valuing and organization levels.
- **7.** Students will learn relevant financial accounting career skills, applying both quantitative and qualitative knowledge to their future careers in business.
- **D.** <u>CORE CURRICULUM</u>: This course partially satisfies the Core Curriculum Requirement for Social and Behavioral Science Foundational Component Area (080).

E. CORE CURRICULUM OBJECTIVES ADDRESSED:

- 1. Communications skills—to include effective written, oral and visual communication
- **2. Critical thinking skills**—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information
- **3. Empirical and quantitative competency skills**—to manipulate and analyze numerical data or observable facts resulting in informed conclusions
- **4. Personal Responsibility**—to include the ability to connect choices, actions, and consequences to ethical decision-making.
- **5. Social Responsibility**—to include the demonstrated knowledge and competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
- **ATTENDANCE POLICY:** Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus. As a course that meets twice per week, after 4 unexcused absences, students will be warned of excessive absences.

Any student not present at roll taking will be marked absent unless <u>prior</u> arrangements have been made. Class will begin PROMPTLY at the scheduled time.

This is a class in which student attendance is required. If a student stops attending class, they WILL BE DROPPED after <u>SIX</u> unexcused absences <u>EVEN IF</u> they continue to complete assignments.

G. The Blackboard software used to manage this online course tracks student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important in order to meet the objectives of this course. Ideally, students should daily check the semester schedule, e-mail, and also check for announcements and fellow student discussions. This course is not 100% self-paced—there will be deadlines. You will feel more at ease with the materials if you stay in touch with what is going on. This course is 3 semester credit hours. For this reason, you should set aside a minimum of 6 hours per week to work on

this course. One of the very first things you should do is set aside time each week to work on the class. It is very easy to put off attendance in an online course.
