## **GENERAL COURSE INFORMATION:**

<u>Course Description: Prerequisites</u>: A study of the design, operation, and technical details of modern power distribution systems, including generating equipment, transmission and distribution lines, plant distribution, and protective devices. It also includes calculation of ground fault current, system load analysis, rates and power economics.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are:

The student will identify the major parts of utility systems.

Compare overhead systems with underground systems.

Discuss mechanical design considerations to meet codes, standards, climate, and terrain relating to utility systems.

Explain electrical considerations for utility lines.

Relate the economics involved in utility lines.

The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
